

## RECORD OF PROCEEDINGS

Meeting of the Evansville Town Council, Evansville, Wyoming

March 28, 2016

The regular meeting of the Evansville Town Council of the Town of Evansville, County of Natrona, State of Wyoming, was held at 7:00 p.m. in the Council Chambers of the Town Hall.

The meeting was called to order by Mayor Phil Hinds at 7:00 p.m. and upon roll call the following were present: Mayor Phil Hinds, Council Members Doug White, Ernie Blackford, Joseph Knop and Jory Delinger, Assistant to Treasurer Alexi Erickson, Chief of Police Tom Laughrey, Fire Chief Leo Malsom, Public Works Director Dan Adcock, Town Clerk Janelle Underwood, and interested citizens.

Town Engineer Shane Porter and Town Treasurer Peggy Nading asked to be excused.

Mayor Hinds led the Pledge of Allegiance.

APPROVAL OF AGENDA: Motion was made by Ernie Blackford and seconded by Joseph Knop to approve the agenda. Motion carried.

APPROVAL OF MINUTES: The minutes for the regular meeting on March 14, 2016, were presented for approval. Motion was made by Jory Delinger and seconded by Joseph Knop to approve the minutes as written. Motion carried.

APPROVAL OF CATERING PERMIT: Town Clerk Janelle Underwood advised the Governing Body that Butch's Happy Days Liquor had applied for a Catering Permit for the UMF Appreciation Party and 5<sup>th</sup> Annual MILF Run to be held on September 10, 2016. She advised that the application along with a map and a letter providing details of the event were provided to the Town and passed along to the Governing Body, Town Attorney Phil Willoughby and Chief of Police Tom Laughrey.

Chief of Police Tom Laughrey advised that he spoke to Mr. Schmidt, the applicant. He stated that it sounds like they are going to have things cordoned off and take all measures to make sure of the people who are allowed in and the people who are not allowed in. He stated that he has no objections to the event. He stated that he has not had any real problems with Butch's Happy Days Liquor and that he might have an extra police officer work during the event.
