

RECORD OF PROCEEDINGS

Meeting of the Evansville Town Council, Evansville, Wyoming

July 11, 2016

The regular meeting of the Evansville Town Council of the Town of Evansville, County of Natrona, State of Wyoming, was held at 7:00 p.m. in the Council Chambers of the Town Hall.

The meeting was called to order by Mayor Phil Hinds at 7:00 p.m. and upon roll call the following were present: Mayor Phil Hinds, Council Members Joseph Knop and Jory Delinger, Chief of Police Tom Laughrey, Fire Chief Leo Malsom, Public Works Director Dan Adcock, Town Clerk Janelle Underwood, and interested citizens.

Council Member Doug White, Town Attorney Phil Willoughby, Town Engineer Shane Porter, and Town Treasurer Lexi Erickson asked to be excused.

Mayor Phil Hinds led the Pledge of Allegiance.

APPROVAL OF AGENDA: Motion was made by Jory Delinger and seconded by Joseph Knop to approve the agenda. Motion carried.

APPROVAL OF MINUTES: The minutes for the regular meeting on June 27, 2016, were presented for approval. Motion was made by Jory Delinger and seconded by Joseph Knop to approve the minutes as written. Motion carried.

APPROVAL OF DEPARTMENTAL MONTHLY REPORT: The Treasurer's report, Police report, Fire report, and the Public Works report were presented to the Governing Body in writing. Motion was made by Joseph Knop and seconded by Jory Delinger to approve the departmental monthly reports. Motion carried.

ORDINANCE #5-2016: An Ordinance Repealing Chapter 13 of the Town of Evansville Code and Adopting an Updated Chapter 13. Second reading. Town Clerk Janelle Underwood read Ordinance #5-2016 by title only. Motion was made by Jory Delinger and seconded by Joe Knop to approve Ordinance #5-2016 on second reading. Motion carried.

CASPER LODGE 30 DAY BUSINESS LICENSE RENEWAL: Fire Chief Leo Malsom advised that the fire suppression system water line was installed last month. He stated that all required tests have passed on that portion of the project. He stated that the contractor now has to install the riser and connect the water line, that tamper and flow switches need to be installed, and that the project should then be completed after all the testing takes place by the Fire Department. He recommended approval for another 30 (thirty) day renewal of the business license.

Motion was made by Jory Delinger and seconded by Joseph Knop to approve the business license for 30 days for the Casper Lodge. Motion carried.

APPROVAL OF BUILDING PERMIT: Building Permit application #4256 was presented to the Governing Body for approval. The application was for a basement finish. Motion was made by Jory Delinger and seconded by Joseph Knop to approve permit #4256. Motion carried.

ENGINEER'S REPORT: No report.

BILLS FOR APPROVAL: Bills were presented to the Governing Body for approval. Motion was made by Joseph Knop and seconded by Jory Delinger to pay all bills and draw treasury upon the same. Motion carried.
