Meeting of the Evansville Town Council, Evansville, Wyoming

October 11, 2021

The regular meeting of the Evansville Town Council of the Town of Evansville, County of Natrona, State of Wyoming, was held at 7:00 p.m. in the Council Chambers of the Town Hall.

Council Meeting Livestreamed via You Tube.

The meeting was called to order by Mayor Chad Edwards at 7:00 p.m. and upon roll call the following were present: Council Members Joe Knop, Candace Machado, Michael Scott, and Cathy Stypa, Town Attorney Scott Murray, Town Treasurer Lexi Erickson, Fire Chief Leo Malsom, Public Works Representative Robert Lewallen, Town Clerk Janelle Underwood, and interested citizens.

Chief of Police Mike Thompson asked to be excused.

Mayor Chad Edwards led the Pledge of Allegiance.

APPROVAL OF AGENDA: Motion was made by Michael Scott and seconded by Joe Knop to approve the agenda. Motion carried.

APPROVAL OF CONSENT AGENDA:

Motion was made by Cathy Stypa and seconded by Michael Scott to approve the Consent Agenda. Motion carried.

APPOINTMENT OF PUBLIC WORKS DIRECTOR: Mayor Edwards stated that with the recent resignation of the Public Works Director, Robert Lewallen has filled in as the temporary Public Works Director, which he has done on two different occasions and has a done a great job. Mayor Edwards stated that he would like to appoint him as the Public Works Director.

Council Member Cathy Stypa and Michael Scott both agreed that Robert Lewallen has done a great job stepping in and taking care of things.

Motion was made by Joe Knop and seconded by Michael Scott to approve the appointment of Robert Lewallen as the Public Works Director. Motion carried.

RESOLUTION #12-2021: A Resolution Correcting a Scrivener's Error in Resolution #3-2021 Pertaining to the Town Council's Support for Placing a Proposition for the Imposition of a 1% Specific Purpose Excise Tax. Town Clerk Janelle Underwood read Resolution #12-2021 by title only.

Mayor Edwards stated that when the Town approved the Resolution, there was an error in the amount that was being asked for. He stated that the resolution designated four million four hundred thousand dollars (\$4,400,000.00) and the actual amount that is being asked for is four million three hundred thousand dollars (\$4,300,000.00), so this would reduce the amount by one hundred thousand dollars (\$100,000.00).

Motion was made by Michael Scott and seconded by Joe Knop to approve Resolution #12-2021. Motion carried.
